### **Abstracts submission requirements**

- Abstracts should be submitted in Ukrainian, Russian or English, typed in the editor of Microsoft Word (font "Times New Roman", size - 15, interval - 1,0). Fields: to the right and to the left -25 mm, to the top - 20 mm, to the bottom - 25 mm.
- Speech abstracts no more than 2 full pages.
- Number of authors no more than three persons.
- Location on the page: in the upper right corner there should be the author's surname and initials (authors), indicating the scientific degree, posts, place of work; through the interval - the name of the thesis (in capital letters, in the centre), through the interval with the orientation on the width of the page - the text of the report. References should be numbered according to the order of the reference in the text. The list of the used references is given at the end of the abstract in accordance with the established requirements.
