- abstracts according to chosen topic of the Conference (*refer to demands to abstracts and the example of abstracts*);
- review of scientific adviser (for students and postgraduates).

## The preliminary registration is required!

### Demands for abstracts:

When sending abstracts it is necessary to name the file - number of sections, the lower dash, last name of the first co-author in Latin letters (2\_Petrov).

1) report volume is up to 3 A4-pages including figures, tables, references (5 positions) with references in the text, pages are not numbered;

2) **margins:** top – 20 mm, bottom – 25 mm, right – 25 mm, left – 25 mm;

3) **Font** –Times New Roman, 15; space – single; abstract text justified;

4) file **format:** Microsoft Word – (\*.doc);

5) **first row** (without paragraph) – last name, author’s initials (plain font, aligned right), position (year of study), place of work (education) without abbreviation, city (plain font, aligned right), country;

6) if there is a co-author – with a new paragraph (2<sup>nd</sup> row), and further as in p. 5;

7) next row – abstract name (Caps Lock, bold font, aligned center).

**The name of the abstract must not coincide the name of the section.**

8) Only **1 picture or table** is allowed. Pictures should be sized more than 60×60 mm, less than 170 (high)×118 (width) mm in \*jpg, \*bmp format.

9) **Sources of bibliographic description** given at the end of the text and issued in accordance with GOST 7.1: 2006 "System of standards on information, librarianship and publishing. Bibliographic record. Bibliographic description. General requirements and rules of assembly".

10) from the next paragraph – last name, initials of scientific adviser (plain font, justified), position, science degree, academic title, place of work, city, country.

**According to the results of the conference the electronic textbook is planned to be prepared, which will be sent to all participants and posted on the website of KNUTE.**
