Academic papers will be assigned with DOI. Due to the results of the conference it is planned to publish Conference Proceedings, which will be sent for indexing to the international scientific database Web of Science.

REQUIREMENTS FOR MATCHING

Papers are to be sent to the following e-mail address: **fntp.konf@gmail.com**. The titles of the files are to be signed in accordance with the surname and initials of the conference participant, indicating the section (for example, Ivanenko_Y_platform_2)

Volume of materials is from 6 pages, font – Times New Roman, size – 14 pt, line spacing – 1,5, indent – 1,25 cm; margins: the upper – 20 mm, the bottom – 25 mm, the right – 25 mm, the left – 25 mm; Text editor: Microsoft Word – (*.doc). Pages are not to be numbered; word transfers are not allowed.

In the upper right corner of the first page UDC should be indicated, below the surname and name of the author (co-authors), degrees, academic ranks are to be indicated as well. Below there is the name of higher education establishment, city, country. Below there are ORCID, ResearcherID addresses (active hyperlink to the profile). In one interval in the center of the page there is the title of the report in uppercase letters, in one more interval the text of the articles is to be placed. In the text it is necessary to distinguish signs "-" and "–", initials and surnames are issued using indivisible spaces: Ctrl+Shift+space.

The text of the article should be placed under the following scheme (**highlighted in bold**): abstract in the language of the article; keywords (no more than 5); the relevance of the research topic; formulation of the problem; analysis of recent researches and publications; setting objectives; presenting main material; conclusions and list of sources used. The list of used sources is to contain publication issued no later than during last five years (recommended).

Drawings, tables are printed with the built-in Microsoft Word editor. The title of the drawing is printed in bold and placed under the center drawing. All drawings must be grouped together as a single object.

Example for design: Drawing (picture) # 1 – Sources of deficient financing. The word "Table" is indicated only once on the left side of the first part of the table (with a paragraph indentation). Example for design: Table # 1 – Classification of

financial resources. The size of the font text of the table text is 2 points smaller than the main font. Formulas are to be placed using the formula editor (the internal formula editor in Microsoft Word for Windows).

After the text in one interval the list of sources used is given in alphabetical order. Citation should be made in accordance with the APA style. Automated link design using the following resources:
