ABSTRACT REQUIREMENTS

The total number of pages is 2 full pages including abstracts and references, font is Times New Roman, font size is 15, interspaced is single, paragraph - 1.25 cm; margins: the upper - 20 mm, the bottom - 25 mm, the right - 25 mm, the left - 25 mm; MS Word must be used to write abstracts (* .doc).

Abstracts should be sent to e-mail **confer_KNUTE2019@ukr.net**. The abstract files must contain the name and initials of the conference participant, with discussion platform (for example, Vasilenko O.P._Tezy_2).

In the upper right corner of the first page the surname and initials of the author (co-authors), scientific and academic degrees are indicated. The name of the higher educational institution, city, country is at next line below. Below there is a profile in Google Scholar or in a different database that contains the author' scientific data (the base name is an active hyperlink to the profile). Then, with one-line interval in the center of the page indicate report title (capitalized letter), Then, with one-line interval, the text of the article.

The references are provided in the next line after the text of the article. The references are given according to the order of using in the text, according to the bibliographic requirements. References are provided in the text in square brackets []. Making references, you should use **DSTU 8302: 2015. Bibliographic link. General terms and conditions of drafting** ", which came into force on July 1, 2016.
